## Diploma in Creative Supervision

### October 2012 - September 2013

**Co-facilitators Sue Jennings, Dramatherapist and Ali Chown, Play Therapist**

This approved training course incorporates a *creative, process orientated model of supervision* for all arts and play therapists, therapeutic storytellers, psychotherapists and counsellors. It is based on the highly successful course that has taken place in London, Ireland and Greece. The uniqueness of this course is that it integrates a range of non-verbal and verbal approaches, drawn from the arts and play therapies into the process of supervision; whilst at the same time maintaining the rigour and standards required for professional supervision.

The course addresses both one-to-one and group models of supervision, that include approaches developed by Hawkins and Shohet, Mooli Lahad, Sue Jennings and other specialist leaders in the field; co-facilitators are Sue Jennings and Ali Chown together with visiting specialists: Dr John Casson, Mary Smail, Dr Ditty Dokter, Linda Winn, Sharon Jacksties, Penny Macfarlane, Claire Shrader. The focus is on the creative process of supervision and the empowerment of the supervisee in addressing both day-to-day and crisis issues in practice.

Course content includes: current supervision theories, live supervision practice, workshops on creative methods, supervision on supervision, student led workshops and book presentations.

**Dr Sue Jennings** who co-facilitates this training course has been practising as a supervisor for over thirty years. She has trained supervisors in Greece, Romania, UK and facilitates an annual qualifying course in Ireland at the Children's Therapy Centre, Ballymore. She has written chapters in *Dramatherapy Supervision* edited by Elektra Tselikas Routledge, 2004 and has endorsed the latest Arts Therapies Supervision series, published by Routledge.

**Ali Chown** MA is a Play Therapist and supervisor and has worked for many years in as a specialist teacher for children and young people with social, emotional and behavior needs. She is currently working as a Play Therapist with children on the autistic spectrum, and with parents and children in need of attachment based play. She continues to work with schools to promote therapeutic approaches and lectures in Child Development and Behaviour for Learning at Foundation degree level.

Applicants for this course (arts and play therapists, therapeutic storytellers, counsellors, psychotherapists) need 2-3 years post-qualifying practice and supervision.
